## TRAVEL DIRECTIONS TO KATC

### By Subway

Take J train to Gates Avenue, walk North two blocks to Lexington Avenue, walk West on Lexington to KATC (1½ blocks)

or

Take the A train to Utica, take the B46 bus on Utica Avenue toward Dekalb Avenue to Lexington Avenue, walk East on Lexington to KATC (½ block)

### By Bus

Take the B46 bus on Utica Avenue/Malcolm X Boulevard to Lexington Avenue, walk East on Lexington to KATC (½ block)

or

Take B52 bus on Gates Avenue to Malcolm X Boulevard, walk North on Malcolm X to Lexington Avenue (2 blocks), walk East on Lexington

## ADMISSION CRITERIA AND PROCEDURES

Questions regarding admission to KATC are directed to our admissions office. When a referral agency calls, the admissions department screens the patient. If appropriate for admission the referent is given a specific appointment for intake, generally within 24 hours of the initial call. A newly established centralized intake system insures immediate admission to any of the Downstate ATCs.

## ADMISSION CRITERIA

- Diagnosis of chemical dependency with or without co-occurring mental health disorder
- Inability to remain abstinent outside of a 24-hour facility
- 18 years of age or older
- Agrees to treatment in a non-smoking facility

## TREATMENT PROGRAM

Patients accepted into treatment are immediately assigned a case manager. This case manager is the contact person for all aspects of the patient's care. The length of stay is clinically driven and is based on the patient's treatment needs. KATC has separate treatment programs based on gender.
